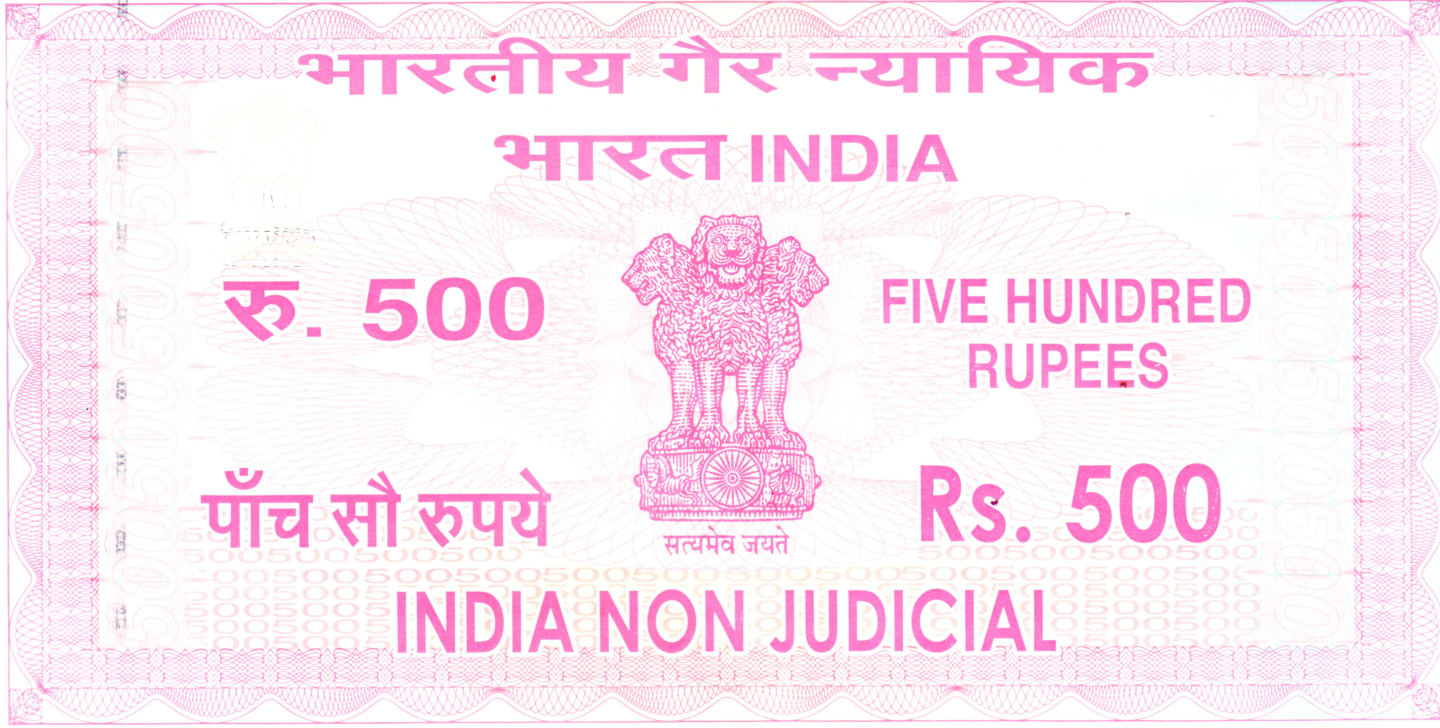

Nagar, Peruvoyal Village, Gummidipoondi Taluk, Thiruvallur District – 601206 (“**Training Partner**”), do hereby voluntarily state, confirm, assure, declare, and irrevocably undertakes to National Skill Development Corporation (“**NSDC**”) as follows:

- (1) That Training Partner has conducted training under Pradhan Mantri Kaushal Vikas Yojana (“**PMKVY**”) 4.0 Scheme in accordance with the applicable laws, Scheme guidelines and directions received by competent authorities from time to time.
- (2) The Training Partner hereby solemnly declares and affirms that:
 - a) all particulars, information, data, records, documents, statements and details forming integral part of the **Claim Verification Documents (CVD)** submitted to NSDC in pursuance of the NSDC’s letter dated 06.08.2026 are true, correct, complete, accurate, and genuine;
 - b) No material fact or information relating to PMKVY 4.0 has been concealed, misstated, falsified, fabricated, or misrepresented, whether intentionally or otherwise.
 - (3) The Training Partner represents and warrants that all data, information, documents, declarations, and statements furnished to NSDC are true, correct, complete, and not misleading.

- (4) In the event that any data, information or document forming part of the **Claim Verification Documents (CVD)** is found to be incorrect, misleading, mismatched, or false; or any misrepresentation is made by the Training Partner, whereby NSDC suffer or may suffer any loss, damage, cost, or liability in relation to the training conducted under PMKVY 4.0 Scheme then:
- NSDC shall have the right to initiate appropriate action against the Training Partner;
 - NSDC shall have the right to recover the disbursed amount ; and
 - The Training Partner shall indemnify, defend, and keep indemnified NSDC, its directors, officers, employees, and agents from and against all claims, liabilities, losses, damages, penalties, fines, costs, and expenses (including legal fees) arising out of or resulting from such acts or omissions.
- (5) That it is agreed that all or any dispute, controversy, claim or disagreement arising out of or touching upon or in relation to the training conducted under PMKVY 4.0 Scheme and the respective rights and obligations of the Training Partner, that cannot be amicably resolved by mutual discussion within 30 (thirty) calendar days, shall be settled as per the provisions of the Arbitration and Conciliation Act, 1996 which shall be final and binding arbitration. The proceedings of the arbitration shall be in accordance with the Rules of Arbitration of the Indian Dispute Resolution Centre ("IDRC") which rules are deemed to be incorporated by reference in this clause and the award made in pursuance thereof shall be binding on NSDC and Training Partner. The seat and place of arbitration proceedings shall be New Delhi and arbitration proceedings shall be conducted in English language.
- (6) This Indemnity Bond shall be governed by and construed in accordance with the laws of India.
- (7) Subject to Clause 6 above, all disputes arising from this Indemnity Bond between the NSDC and the Training Partner shall be subject to the jurisdiction of the Courts at Delhi/New Delhi only.
- (8) This Indemnity Bond shall be irrevocable and shall remain binding on the Training Partner at all times.

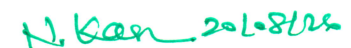
